### HOW TO ATTEND & PARTICIPATE

**C**lub Deportivo's Annual Membership meeting and Election of Officers will be held on **Saturday, February 13, 2021**, at **9:30 a.m.** Due to COVID restrictions, we will not be able to meet together inside as in the past.

This year's meeting will be conducted principally as an online remote ZOOM meeting. Most internet devices with a microphone, display screen, and camera can support attendance via ZOOM for both audio and video participation. Members can join the meeting with audio and video via the internet on a computer, tablet, or internet cell phone. You can also join for audio only via telephone landline or cellular telephone.

For more information on ZOOM you can visit the site online at [ZOOM.US](https://zoom.us). From our experience in Kino, ZOOM does require an internet data connection adequate to stream video. We can also recommend that once you get the meeting link, you test whatever device you plan to use ahead of time or start the process to join the meeting at least 15 minutes before the meeting starts.

## ATTENTION all you boat Captains out there!!

I just had a meeting with the Kino Bay Port Captain. He informed me that in the future the Mexican Navy is taking charge of all boating activities.

Due to this change there are some new rules that we need to be aware of. The number one rule is that to operate your vessel here in Mexico you need to have a valid operators license. This is to show that you are competent to operate the vessel you are on. In the future—not sure when, but probably by years end—this will be required. If you are stopped by the Navy and you do not have a valid operators license, a fine can be imposed. At that time the Navy also will be checking for safety gear required onboard. Basically the same as the US Coast Guard does in the US.

Any state approved safe boating card will work. If you do not have a valid boat operator's license, there are a few online courses that can be taken to obtain this that will also be valid in your home state of residence. It is also possible that Club Deportivo could have a course put on with people from Guaymas to obtain this license. One problem would be that you would need to go to Guaymas to get your license after attending the course. Seems to me to be much easier to get one online.

## Reporting Period: 25 November, 2020 to 26 January/2021.

**Note:** Missing dates normally mean that the wind contributed to boats not going out to fish.

**NOTE:** This report goes back to November 23, due to lack of information and some windy days limiting going out. Not many people are getting out to fish due to this, boat problems, and not returning to Kino so far this year. Hopefully this will change as the weather warms a little.

**11/25/2020** SAND DOLLAR fished south of Turner for three Yellowtail and then bottom fished for nice Rockies. NIGHTWINGS fished south of Turner jigging for three nice Yellowtail and then Dead Man for only triggerfish. A move to Colorado Risco provided a good catch of Goldies and Rockies in addition to a double hook-up on Pinto Bass/"Pinta" which weighed 12.5 and 41.5 pounds (my biggest ever by far).

**11/30** NIGHTWINGS shore fished Christmas Tree/ Santa Rosa point for three Cortez Halibut (one released) and "Sandies" but generally very slow for this time of year.

**12/02** NIGHTWINGS returned to Christmas Tree for two Halibut and a couple of Sandies. No sign of reported Pompano or Corvina but heard of a 10K Halibut caught there earlier in the week. A few days later a group of 15 fishermen fished all day for one halibut and a few corvina.

**12/09 - 01/13/21** Upon returning to Kino, I spoke to a few fishermen and local workers about the recent fishing. Windy weather was the rule more often than not and catches were mostly limited to bottom fish. Especially towards the end of this period, yellowtail catches were reported to be non-existent. Most fishermen were trolling only, so some hypothesize that the scarcity of bait

fish schools may be effecting the catch. There were large numbers of purse seiners in the area this past summer and bait schools have not been seen as often. Since 2017 this harvesting practice has become common in the midriff area and undoubtedly has effected the fishery. I have heard similar reports from the fishermen in San Carlos. There could be Yellowtail out there still but at greater depths than trolling exploits. Again, maybe I have just heard from those catching fish out there.

Another "low point" to fishing this season was the poor showing of halibut along the beaches, primarily the Santa Rosa area. I did hear some good reports for corvina and pompano, which I caught the tail end of, but very few Halibut reports, especially as compared to the past ten years in my experience.

**01/17/21** ESCAPE went to Turner and Colorado Risco for bottom fish and SAND DOLLAR also tried the same areas in deep water for bottom fish and reported really rough water.

**01/18** SAND DOLLAR fished 14 Mile, then the south end of Turner for bottom fish and a 30 pound Baqueta Grouper. They also reported sighting Fin Whales. NIGHTWINGS returned to Christmas Tree on a calm day and slack tides but not many fish; one Scorpion Fish, one Sandie and one six pound Halibut.

**01/23** SAND DOLLAR fished Turner to Colorado Risco for bottom fish.

**01/26/21** Checking in with "San Carlos fishing" I saw a reports of very slow fishing which has recently changed to sightings of the return of bait fish schools and red crabs masses which have brought up "square kilometer wide boils of fish at the island" (Isla Pedro Nolasco).

They seem to think the Yellowtail are migrating north at this time and fishing should begin to improve. "Fake news" or "Reason for hope"?

**CLUB DEPORTIVO**  
**ANNUAL MEETING OF MEMBERS**  
**FEBRUARY 8 2020**

1. **CALL TO ORDER**: The meeting was called to order at 9.00 am by President Anne DeFrance.
2. **MINUTES OF THE PREVIOUS MEETING**: The minutes of the February 9 2019 Annual General Meeting were reviewed. Moved by Lynn Curtis, seconded by Dr. Dale Kemmerer to approve the minutes as submitted. Motion carried.
3. **OFFICER'S REPORTS**:
  - a. **President's Report**: Anne DeFrance, gave the President's report for 2019/2020. She welcomed members and thanked them for attending. She discussed the Comodato and outlined for members the issues facing the club. There were indications received that the State of Sonora was considering either taking back what appears to them to be unused land (parking lot and storage lot) to sell to raise revenue or perhaps revoking the Comodato altogether. A Committee was formed to investigate further details, and this committee has so far recommended the following: Find out how much money we would need to fund a purchase: Prepare Intent to Purchase paperwork: present a plan to the Membership and update the Club's Record of Service. As of this meeting the Board is not yet ready to recommend any action to the membership. Another acute issue before the Board is shrinking membership and loss of revenue. She reviewed past plans for this issue. Charts outlining income and revenue were presented, showing that just in this past year we spent \$5,000 USD in excess of income,, due to needed maintenance and repairs to the aging building. To this end, she requested members to form a Committee to review ways of increasing income and decreasing expenditure. Names will be taken by Secretary Maggy Becker at the end of the meeting. One of the misconceptions in our community is the funding given to local charity. At present 10% of membership fees is set aside to help requests from the local community, and the Benefit Dinner
  - b. The Club receives 20% of Benefit Dinner money, and the balance is specifically set aside for charity. President DeFrance went on to thank all the many people who have helped her in the 2 years of her service as President.
  - c. **1st Vice President's Report**: Ron Leetch began his report thanking everyone for attending the meeting. The last 12 months have been busy, with a total of 748 boats checked out wit 2822 people aboard. There were 9 boat assists handled by Rescue One, and one land rescue as well as one emergency call for police. In the 5 reporting months for Rescue One First Responders there was a total of 186 non emergency encounters. A sign was put up for a basic first aid course, with no sign ups. Dr. Kemmerer has stepped aside as lead person but is still seeing people who need help. We are in the process of getting ready to change Rescue One VHP channel from 24 to 26. A ramp maintenance fund was started for ongoing repairs, and so far it stands at 18,200 pesos.
  - d. **2nd Vice President**: Laurel Hakim said a big part of the 2nd Vice President's position is Community Outreach. We provide backpacks, with school supplies to elementary students, and we provide birthday gifts for students in the Breakfast Program. This position appoints and oversees the Humanitarian Award Committee, the Fundraising Committee and the Charitable Giving Committee.

All of these Committees provide help and support to the local community and are essential parts of the Club Deportivo interaction with local residents.

- e. **Treasurer's Report:** Joan Fairweather addressed members on the financial status of the Club. She addressed the \$5,500 funding needed for maintenance and repairs which exceeded the budget for the year, and had to be borrowed from the General Reserve, whereas we usually put funds into this Reserve instead of taking money out. We have reached a critical point in our history and we need to make changes if we wish to continue operations. For this reason, I urge members to help by joining the Committee called for by President deFrance and sign up by giving your names/contact information to Secretary Maggy Becker at the end of this meeting. She reviewed income and expense for the year and showed the balance sheet on charts. She ended her report by saying we cannot keep taking money from the General Reserve but must contribute to it in the future if we are to keep operating.

#### 4. **DIRECTOR'S REPORTS:**

- a. **Bar:** Paul Stanley gave his Bar Report: we had a bar requirement for about 25 events including golf course, patio, social hours, dinners and special events. We are losing deposits on returnable bottles which are not returned and future beer supplies will be purchased in cans only. Some increases in prices has been necessary to cover rising costs of supplies. Research shows that our prices are on average 20-40% lower than local restaurants and bars. He extended special thanks to Gale Lenihan for stepping up and taking responsibility for scheduling bartenders for activities.
- b. **Communications and Library:** Director Marla Anderson said serving on the Board of Directors has been very interesting. She concluded that this experience showed her the importance of volunteer work from the community and the need for each member to consider volunteering a little time so the club remains a great service for all. She thanked Sandie Burnham for keeping the library organized and in great shape, Carolyn Kinsman for producing the monthly newsletter and, Carolyn Martine for being our calendar girl, Bev Kolosseus for maintaining our web page and our always courteous and helpful staff, always willing to lend an extra hand.
- c. **Maintenance and Construction:** Director John Nicola said that as always his main job is to spend Club money, and hoped that so far he had done a good job on that. The west wall of the clubhouse was updated with wall and glass block to replace the sliding glass windows, major roof leaks repaired, and the kitchen floor stripped and regouted. Plans to install new toilets were put on hold due to the uncertainty of the commodato issue. This is his last year and the Club will be seeking a replacement for next year.
- d. **Indoor Activities:** Director Sandra Johnston said she had learned a lot about the Club during the last two years. She and her husband joined for the wonderful social life it offered and spend a lot of time there. She enumerated the many activities on offer to members and thanked everyone for their support.
- e. **Meals:** Director Rick Hussey reported on the past year's activities in the kitchen. First he thanked everyone who helped out preparing meals or entertaining during meals. For the fiscal year ending September 2019 our kitchen prepared 10 breakfast meals, 9 dinner meals and several lunches. On average breakfasts were attended by 61 members and dinners served 127. The kitchen contributed



almost 20% of the operating budget, however we fell a little short of goal due to increased costs. We have taken action this year to improve the kitchen contribution without impacting sponsor fees or meal ticket prices. We have added meals extending the calendar to May and have worked hard to

- f. provide a good variety of meals, including a few specialty meals to spark interest and attendance. This season we are working with several new organizers and chefs who are bringing new ideas and flavors to meals. Finally a huge thank you goes to Judy Hazen for all she is doing to recruit and coordinate our organizers and sponsor.
  - g. **Outdoor Activities:** Director Bill Chisholm reported that the season activities have been well attended and successful, due in large part to the many volunteers. Thanks go to them for making my job easier, and for your ideas and support. We offer ladies bocce, putt-putt, pickleball, and more. The shooting range and horseshoe pits are also available but used sparsely. We had 5 Goathead tournaments and also tournaments for putt-putt, bean bag and Bocce, with a total of 315 participants. We are showing a drop on Goathead tournaments from previous years, probably due to declining membership as a result of this is a reduction of proceeds to maintain outdoor facilities, and the Board decided to increase the percentage of activity registrations from 20% to 30%. We have eliminated some activities and added others, but in all Outdoor Activities continue to be well supported. Fellow Directors and Club staff have been extremely helpful and all are to be commended for support and participation in activities.
5. **UNFINISHED BUSINESS:** None.
6. **NEW BUSINESS:**
- a. **Bar Tips:** There is currently about \$1,500 USD in the Bar Tip fund. No allocations of this money has been specified. After discussion the following suggestions were made:
    - 1. Renovate bathrooms.
    - 2. Allocate to Ramp Fund (Irwin Perry said he would match any such donation)
    - 3. After School programs.
    - 4. Allocate to the General Fund.

After discussion by the membership, it was agreed by a hand vote to allocate funds to the bathroom renovation, and the remainder to the Ramp maintenance. Incoming future tips would be allocated to ramp maintenance.

- b. **Members Comment and Participation:** Judy Hazen asked for meal sponsors and organizers. Carolyn Martine requested that this information be given to her asap to help with the calendar. Rick Harris asked how much interaction and communication there is with local population about ramp use and maintenance.
- c. Betty Martinez responded that a directory is being compiled but as yet no donations have been requested. This will be a Board decision. For the upcoming new Board of Directors. Paul Stanley said that there is no funding from the club to ramp maintenance and he will be addressing this in the future. Dr. Dale suggested asking Finisterra to contribute.

- d. **Nominating Committee**: Francine Bailey thanked the Nominating Committee: Francine Bailey, Marlayna McKenzie, Anne Stern, Sandie Burnham and John Hazen, for their hard work. Marlayna McKenzie presented the slate for members for the upcoming terms:

1. President: No nomination
2. Outdoor Activities: Kent Ogden
3. Indoor Activities: Anne Stern
4. Communications and Library: Ray Kolosseus
5. Secretary: Ronna Mann
6. 2<sup>nd</sup> Vice President: Craig Gresham

We are still looking for a President.

President Anne DeFrance thanked the Commtee. She requested nominations from the floor as follows:

1. **2<sup>nd</sup> Vice President**: No nominations. Moved by Sandie Burnham, seconded by Francine Bailey to approve Craig Gresham by acclamation. Motion carried.




